DISCOUNTS

- MULTIPLE-CHILD DISCOUNT:** Discounts for families with more than one child enrolled in CPCS are indicated in the chart above, on a descending scale, beginning with the child in the highest grade.
- FULL-PAYMENT DISCOUNT:** A 3% discount on tuition only will be available if all accounts (including ALL fees) are paid in full by June 15.

WITHDRAWALS

Annual tuition is configured on a full-semester basis. Installment payment plans are calculated based on 12 monthly payments beginning June, 2026 through May, 2027. **Withdrawals require written notification to your campus Admissions Office.**

- Written withdrawal notification received after August 1st:** Payment for the full first semester is required.
- Written withdrawal notification received after December 1st:** Payment for the full second semester is required.
